Information

1. Application for participation in the Conference and the article

To participate in the Conference, you should fill in an Application form (available on the website: <http://step-into-the-future.ru>) and draw up an article highlighting the contents of your presentation at the conference. The application and the article should be written in English.

The filled-in application form (or applications in the case of many authors) and the article should be sent to apfn@step-into-the-future.ru **before January 15, 2020**. Please, write down in your letter in the subject line (Re:): "Application for ICRES'2020. Article (*full names of the authors*)". The following can be used as file names: "Article (names of the authors)", "Application (names)". Upon receipt of the documents, the Organizing Committee will send a confirmation letter to the author's e-mail address.

2. Report at the Conference

The working languages at the Conference are Russian and English (simultaneous conference interpreting will be provided). Time of plenary reports will be 15-20 minutes, subpanel reports - 10 minutes. After the presentation, time for answers to questions will be provided. A presentation on PC should be prepared for your speech. The presentation file should be sent for technical verification before **March 5, 2020** to e-mail address: apfn@step-into-the-future.ru.

3. Execution of the Article

The text length of the article should be min. 3000 (three thousand) words, but no more than 8000 (eight thousand) words, including the list of references.

The article should contain the following key items:

- title of the article (without acronyms and abbreviations),
- abstract (100-120 words),
- keywords (5-8 words or word combinations),
- text of the article,
- list of references.

The text of the article should be subdivided into Introduction, a basic part (one or more entitled sections), Conclusion.

The text should be printed at 1.5 line interval, Times New Roman font, 12 pt. All titles should be centered. The title of the article should be printed first - the article heading (*without acronyms and abbreviations*), next line is full name of the author, the line below is name of the country, city, place of work (*in full*), position (if the author is employed in many companies, the author's places of work are separated by semicolon), a scientific degree, an academic rank, honorary distinctions (*if any*).

An abstract and keywords are bellow the title, next is the text of the article with all necessary materials (*tables, diagrams, etc.*). References to literary sources should be shown in square brackets and numbered by Arabic numerals [1], [2], [1, 5, 8]. Titles of literary sources in the order as mentioned in the text are shown at the end of the text of the article under the "References" line. The article should contain min. 8 (eight) references to scientific sources (publications in scientific journals, collected works, monographs, dissertations).
